### ***Príloha č. 1 – slovník pojmov***

**Emergency powers** - prezidentova právomoc konať v časoch mimoriadneho stavu ako je napr. vojna

**Executive order** – prezidentský dekrét/vyhláška, ktorá má platnosť zákona bez potreby súhlasu Kongresu a oficiálne zverejnený vo Federálnom registri, čím nadobúda legitimitu

**Executive action** – prezidentský dekrét/vyhláška, ktorá však slúži len ako smernica prezidenta vláde či iným zložkám exekutívy ako vykonávať určitý akt

**Gridlock** – stav bipartizmu, kedy je prezident z jednej strany a väčšina v Kongrese alebo aspoň v jednej komore z opozičnej strany

**Impeachment** – Oficiálny proces obvinenia formálneho úradníka – prezidenta – z nezákonnej činnosti

**Job approval** – Výsledok verejného šetrenia otázky „Ste spokojný s prácou, ktorú odvádza XX ako prezident?“

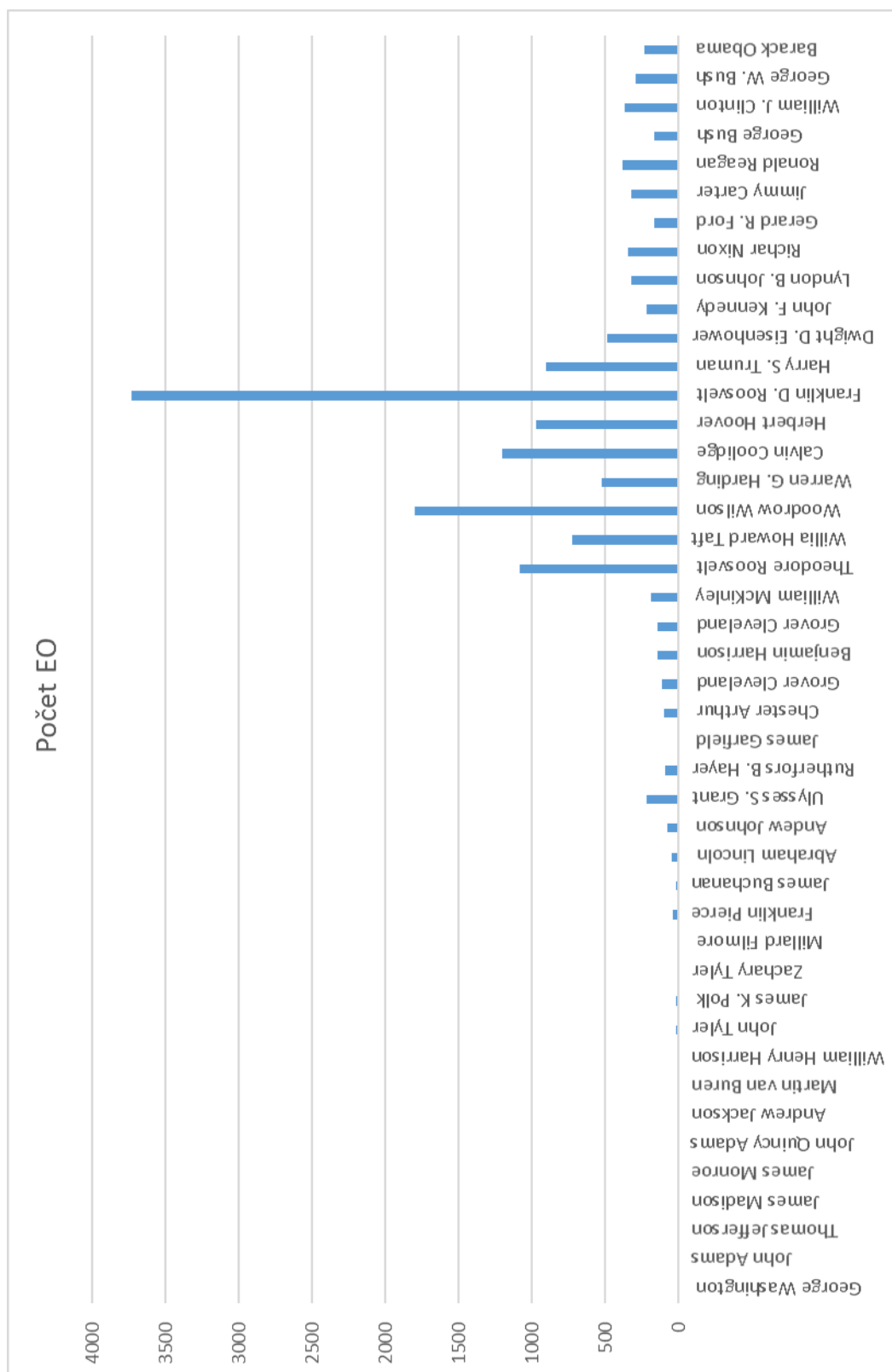
**Late-term/first-term order** – executive orders vydané v prvom/druhom volebnom období prezidenta

**Policy-making** – spôsob a akt vykonávania prezidentovej politiky a agendy

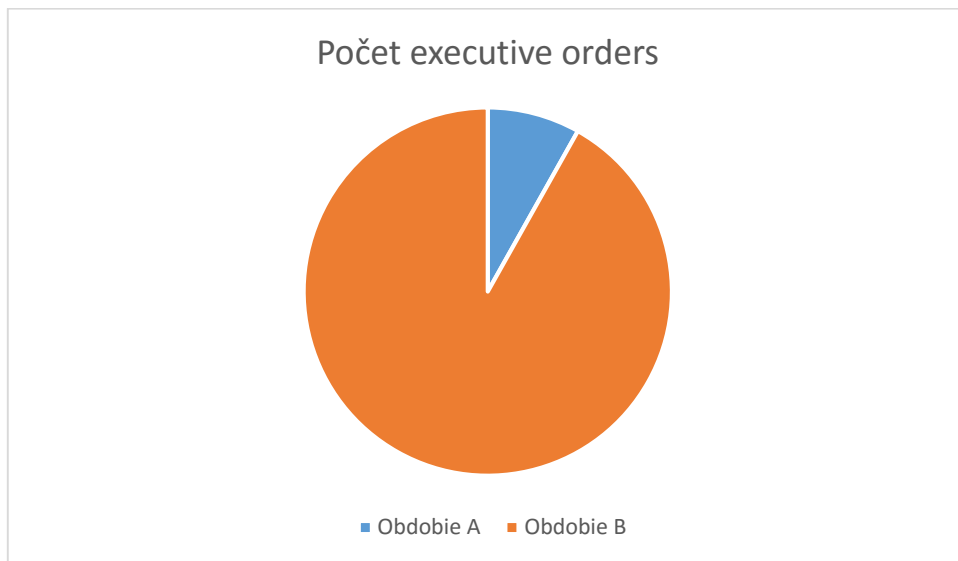
**President-centered** – chápanie úradu prezidenta so zameraním na osobu

**Presidency-centered** – chápanie úradu prezidenta so zameraním na úrad

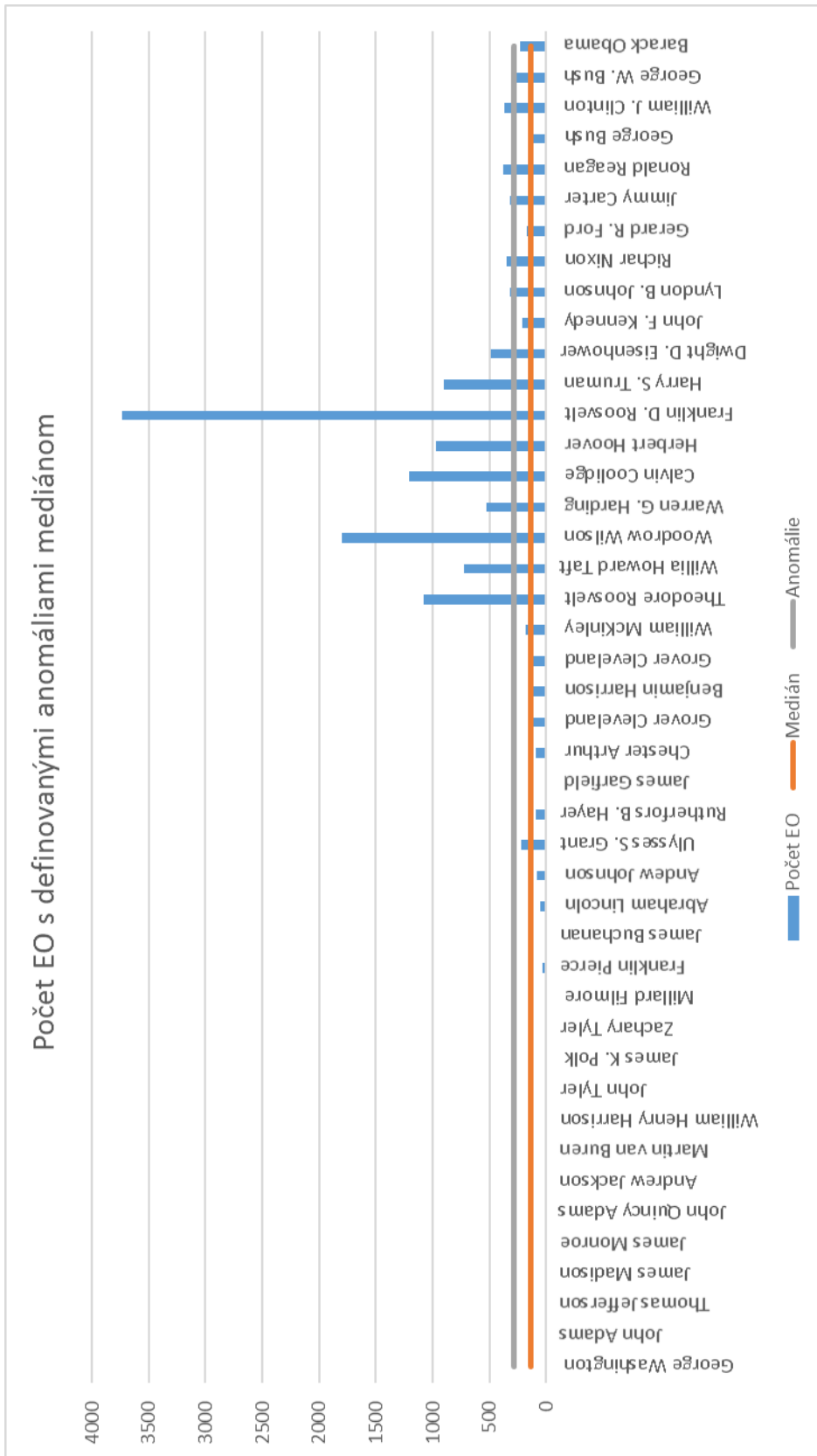
## Príloha č.2 – počet vydaných EO na prezidenta
