OVERALL ASSESSMENT (provided in English, Czech, or Slovak):

The main aim of the thesis is to follow the famous paper of Rama Cont (2001, Quantitative Finance) and compare the statistical properties of the most traded crypto-currencties with the stylized facts about other asset classes – mainly stocks (stock indices) and FX rates. This is reflected in a rather unothodox structure of the text, i.e. a mixture of methodology and results, which, however, pays off quite well here. Samuel has performed a detailed analysis of Bitcoin, Litecoin, and Ripple. Even though the analysis is affected by data issues connected to a historical erratic behavior of the crypto-currencies, the results are quite straighforward.

The thesis brings forward interesting results and the analysis is undertaken properly. The biggest issue is in the results reporting. The results are rather stated and not really explained or discussed, which is a shame. The text then sometimes turns into a statistical exercise without evident contribution. Due to this, I believe the thesis does not deserve the highest points, yet still it passes for the **grade A**.
