OVERALL ASSESSMENT

This thesis analyzes the potential role of stock markets in predicting changes in macroeconomic variables.

The thesis contains 36 pages followed by the bibliography and appendix. Chapter 1-6 introduces the topic and present detailed literature and theoretical background of the subject. The background literature on the stock markets variations and macroeconomic variables provided in chapter 2-3 demonstrates the authors' clear understanding of the subject.

Chapter 4 presents the methods used in the thesis to analyze the role of stock market in predicting changes in macroeconomic variables. The time series methods used in the thesis are standard methods for this kind of research and the author seems well versed in the methods used here. Chapter 5 presents data and chapter 6 presents the analysis of the results and concludes the thesis. The conclusion answers all the questions raised in the introduction to the thesis.

Suggested question for the defense:

Things like financial news etc are expected to affect stock market a lot more than macroeconomic variables. What do you think are some of the factors that would affect the stock market but not necessary the macroeconomic variables in question? What kind of methodological issues that might raise for you? And do you think your conclusion?

This is a high quality work for a student writing bachelor thesis and the student used a very standard approach and econometric methods to answer the questions raised. In case of successful defense, I recommend "vyborne" (Excellent, 1)
