Contribution

The thesis is an original contribution to important policy question regarding the central banks. The thesis examine the monetary policy effectiveness in zero interest rate environment. The article by Swanson and Williams (2014) published in the American Economic Review provides a theoretical model stating that the central bank actions (including communication) become impotent under zero lower bound on interest rates and show that the sensitivity of interest rates to macroecomic news represents a measure of monetary policy effectiveness.

Two other papers have tested this premise using the data – i.e. whether interest rate reaction to macroeconomic news is weaker under the zero lower bound contraint (Swanson and Williams (2014) in Journal of International Economics with US data and Moessner et al. (2016) in Contemporary Economic Policy with Swedish data). This thesis tackles the same question but with more recent data (therefore covering the period of zero lower bound environment in a fuller manner) and examining the effect of central bank communication with richer dataset (previous literature examined the effect of communication on less macroeconomic variables than this thesis). The results indeed suggest that monetary policy effectiveness decreases under the zero lower bound constraint.

Methods

The author compiles a rich dataset of macroeconomic news in the US and use this data to estimate the effect on interest rates using the ordinary least squares. This method is appropriate in this setting. The substantial robustness checks are conducted.

Literature

The literature is well-cited. All important references are covered. The discussion of previous literature is excellent and it is clearly stated what the novelty is vis-a-vis prevous literature.

Manuscript form

The thesis reads very well. The author is clear in the arguments and thesis is well-structured. I could not find abstract in the thesis, only saved separately in the SIS but it is minor issue for me.

Overall, the thesis represents fine empirical work on important but underresearched topic. Its contribution is so large that I would find the thesis defendable for the M.A. thesis as well.
