Contribution

The thesis is an original piece of work proposing an economic model that has a potential for the explanation of quoting behavior of a market-maker. The author proposed an original model based on self-exciting point processes that capture differences arising from different regimes and estimate these differences on limit order book data. The contribution is also in new estimation procedure proposed by the author, that is based on novel deep reinforcement learning. The author brings several interesting findings about the behavior of market-makers. The work is contributive to the market microstructure literature, and results are publishable in respected journal interested in these types of contributions (I do not doubt that Quantitative Finance journal would be interested in publishing the results after rearranging to the proper form of paper).

Methods

The author proposed his own models based on his economic intuitions about the behaviour of market-makers. I must stress that although we have been discussing the ideas broadly and on a very regular basis, all ideas are original and independent work of Rastislav. While the work with microstructure data is technically demanding, Rastislav developed his own efficient packages that allowed large-scale simulations to understand the behavior of proposed models. Also, the developed code adapts proposed estimation frameworks and estimates the models on real data. From this perspective, Rastislav showed very strong command of the economic model building, statistics, econometrics, and also efficient programming (the main code is written in C++), and spend large amount of time with the work.

Literature

Rastislav demonstrated a deep understanding of the literature and gives credit to all important as well as relevant studies. The author works with relevant literature properly and develops his own original ideas based on proper understanding of the previous literature. With this respect, Rastislav provided excellent work.

Manuscript form

The text is logical, well written, connects findings to the existing literature well. Rastislav worked consistently to obtain the results for long period, and we have discussed the results and text on a regular basis during the year.
