Contribution

Bachelor thesis, prepared by Anna Pavlova inquires the life satisfaction in the Czech Republic starting from 1991 till 2016 year using different characteristics. Methods

Summary and suggested questions for the discussion during the defense

The analysis performed by Anna in her bachelor thesis done on proper level, paying attention to detailes of characteristics that correlates with life-satisfaction. Nevertheless, subject of life-satisfaction for a long time has been the subject of philosophical hypothesizing. Lack of sufficient measures of life-satisfaction can cause big differentiations in resuls. Thus it would be good to specify what life-satisfaction is precisely. Reaching to unbiased results, when comparing different surveys it is important to pay attention not only to different scales, but also to methods used, for the life-satisfaction measuring.

Suggested questions:

- 1. Can life-disatisfaction be measured?
- 2. Would it be possible to state a hypothesis for further research based on this research?
