Contribution

• Contribution of the thesis could be more spelled out in the introduction as well as in the text itself. The main value added seems to be application to the Czech data. Only results are discussed, one would be also interested in the policy discussion (e.g. what the results mean and how should czech car industry (or posssibly czech government) react.

Methods

Based on the discussion of the pros and cons of the methods provided in the thesis, the
method used seem to be appropriate. Given the variety of approaches in the literature one of
alternative models could be added to check the robustness of the results (e.g. gravity models).

Literature

• Relevant literature appears to be covered fairly comprehensively. Synthetisizing a literature a bit better to convey main messages could be improved.

Manuscript form

• The manuscript form is the weakest part of the thesis. The individual sections and subsections are not numbered, making readers life a bit hard. Captions of tables are not consistent sometimes the name appears above (e.g. table 2) and sometimes below (e.g. table 3). The appendix 3 (closure of the model), 4 and 5 could be discussed bit more.

Summary and suggested questions for the discussion during the defense

The thesis attempts to evaluate the effects of the TTIP agreement on czech car industry and uses CGE-GTAP. Overall, the thesis seems well executed and therefore I recommend it for the defense.

Questions for the defense:

- Can you discuss alternative approaches to estimating the impact of the TTIP and their advantages and disadvantages? Could you elaborate why did you choose GCE-GTAP model?
- How would you summarize the literature on the estimating the impact of the TTIP? What is the average effec that the literature implies? Do you see any patterns in the variation of estimates depending on the method used, country under study or type of data used?
